Tedex AN machine oils are produced on a base of high-quality mineral oils obtained from such processes as hydrotreatment and hydrocracking.

Usage

Tedex AN machine oils are used mostly for lubrication of lightly loaded machine parts and industrial devices (plain bearings, rolling elements bearings, linear motion bearings, closed and open gears, spindles etc.) and other friction nodes that don't require oils with enhancing additives.

Tedex AN machine oils are miscible with L-AN machine oils produced by domestic refineries and can be used in their place, in respectable viscosity classes by ISO. Due to usage of deeply refined base oils, **Tedex AN** oils are not classified as cancerous in work environment, furthermore they are characterized by light colour and higher quality and lower

pour point in comparison with AN machine oils supplied by other manufacturers..

OHS and firefighting properties

Information on safe usage and potential dangers, safety measures, first aid along with information on environmental impact and disposing of used products can be found in MSDS product characteristics card.

Storage and transport

Tedex AN oils should be stored in closed containers protecting it from moisture, water and mechanical impurities. The recommended storage temperature is between 5°C to 35°C. Oil can be transported in bulk, barrels and other unit packages by road or rail, since it does not pose any threat.
